

Clearer power plan for North released

THE STORMONT government considered building a nuclear power station on the site of the recently discovered lignite field in the Lough Neagh basin, according to confidential Cabinet minutes released by the Northern Ireland Public Record Office yesterday.

In May, 1957, the Minister of Commerce, Lord Glenavon, circulated a memo on the issue. For technical reasons he advocated a site in the Washing Bay area on the south-west shore of the Lough.

A determining factor was "the policy of avoiding the vicinity of well-populated areas" laid down by the British government, and the need for ample supplies of water and some means of disposal of the waste. The significance of this factor, the minister wrote, was "increased by the fact that some of the waste water may be, from time to time, slightly radioactive."

Attacks on Catholics were played down by minister

THE tendency of the Stormont Government of Lord Craigavon to play down the anti-Catholic nature of the bitter riots of 1935, in which 11 died and many were ejected from their homes, is revealed in the minutes of the Stormont Cabinet files, according to the Northern Ireland Public Record Office.

In July 1935, the Nationalist MP, Mr T J Campbell, KC, tabled a question in the Stormont House of Commons asking the Minister of Commerce, Sir Dawson Bates, to state the reasons for the disturbances which took place in the Lough Neagh area during the summer of 1935.

Border campaign

THE IRA border campaign in the North in 1957 escalated with the raid on Brookborough RUC station in which South and Fergal O'Hanlon were killed. In the morning, the Prime Minister, Lord Brookborough, reported to the Cabinet on a recent meeting with the British Home Secretary, Mr Harold Clegg, in which the IRA activities and also his appreciation of the IRA's role in the border area were discussed.

The Home Secretary had expressed concern about the IRA's role in the border area, and the Stormont government had agreed to take steps to improve co-operation and control intelligence activities.

Book banned

THE reasons for the banning of the Flaming by historian Desmond Ryan from Belfast Prison in the late 1940s emerge in a Cabinet file released this year. In November 1949, the Nationalist MP, Mr Midy, asked the Minister of Home Affairs, Mr J H Robb, KC, to state the reasons for the banning of the book. Mr Robb, KC, replied that the book had been banned because it was "a book of lies, inaccuracies and mis-statements."

He referred in particular to Ryan's account of the attack on the G.P.O. on Easter Monday, 1916.

He informed Mr Maguire that the book had been intended for Mr Hugh McKee, a former Chief of Staff of the IRA, who was then serving a sentence for treason felony.

Secrecy advised after Windscale

It would be inadvisable to make any public announcement now "because of the widespread publicity given to the recent incident at Windscale," the minutes of the Stormont Cabinet files, according to the Northern Ireland Public Record Office.

The Minister of Health, Mr J. Andrews, thought it prudent, in view of the Windscale accident, to ascertain whether the public health experts had anything to add to their reports.

The possible contamination of Lough Neagh was a matter of considerable concern, he said, especially in view of its value as a reserve supply of drinking water. A sea coast location was still worth considering.

The Minister outlined how the power station would operate: "An adequate supply of water was needed for cooling purposes, the bulk of which would not be in contact with radioactive material. The material would be collected in tanks and released in small amounts under careful control."

Lord Glenavon took the view that the tanks would be taken out to sea and dumped. "He emphasised that a public inquiry would be held beforehand."

Reports by Dr Eamon Phoenix

As in previous years, a number of the files pertaining to 1957 or earlier have been subjected to a "black" or a "partial closure" for up to 75 years. Thus, a Ministry of Home Affairs file on the escape of IRA prisoners from Derry Jail in the early 1950s remains closed until 2040, while other material of 1952 includes a file on "Hunger Strikes in Belfast Prison" during the period 1936-43, and one dealing with an attack by a mob on a parish priest at Cough Co. Tyrone in 1928.

The 1957 Cabinet files released under the "Thirty year rule" were disappointing in their surprising lack of material on the IRA border campaign of the late 1950s which reached its zenith in that year. There were, however, revelations in a number of areas, notably changes in the procedure for Stormont elections; the treatment of voluntary schools and a Cabinet proposal to build an atomic power station in the Lough Neagh region.

The 1957 Cabinet



THE Northern Ireland Cabinet in 1957 was headed by Lord Brookborough, Prime Minister (above), and included in addition, Captain Terence O'Neill as Minister of Finance and Deputy Prime Minister; Mr W B Topping (Home Affairs); Major Ivan Neil (Labour and National Insurance); Lord Glenavon (Commerce); Rev Robert Moore (Agriculture); and T L O Andrews (Health and Legal Government). The Education Ministry was filled by the former Labour MP, Harry Midgley until his death in April 1957, when he was succeeded by Mr Morris May.

THE BROOKBOROUGH Cabinet advised the British Home Office in 1957 to sack 40 workers in armed services establishments in the North because of suspected IRA sympathies, according to the Cabinet files.

In March 1957, the Minister of Home Affairs, Mr W B Topping, circulated a memo to the Cabinet advising that certain civilian employees in army and naval establishments in Northern Ireland were "undesirable" from a security viewpoint. The IRA raids of the preceding few months had made the question one of immediate urgency.

"A situation has arisen," the Minister wrote, "in which a number of employees of the Service establishments are known to be members of or sympathisers with such organisations as the IRA and the Imperial Department concerned have asked us to consider the implications of retaining for the dismissal of these employees."

It was finally agreed that the Home Office should be informed that Ministers were aware of the opinion that the republican sympathisers should be discharged where a transfer to Britain was not feasible, and that there should be an appeals procedure.

THE Stormont Cabinet tried to frustrate the appointment of a citizen of the Republic as Chief Executive of the cross-border Foyle Fisheries Commission in 1957, according to the Stormont Cabinet files.

In April 1957, the Minister of Commerce, Lord Glenavon, circulated a memo to the Cabinet dealing with the application by the Commission for an employment permit to enable it to appoint an "Eire Citizen" to the new post of Chief Executive Officer.

The Stormont Cabinet hoped that the Northern Ireland government would give careful consideration to the issue before taking an irreversible decision. "There were points of view to be considered and repercussions to be avoided other than those which might ensue if a permit were granted."

At a Cabinet meeting on May 8, 1957, Lord Glenavon stated that efforts to reorganise the duties of the Commission's staff in order to avoid the expense of appointing a permit were unsuccessful. It was now clear that the refusal to grant a permit would be regarded by the Dublin government as "showing a lack of the spirit of co-operation upon which the Commission had been founded."

RUC escort for Valera sparked row

AN RUC decision to provide a police escort for the Flannia Fall leader Eamon de Valera in 1957 was the source of a minor crisis at Stormont, according to the Cabinet papers.
